

CONDITIONS: I (We) agree to pay all tuition, fees and charges incurred by the Student at the School, and acknowledge that our obligation to do so is unconditional. I (We) agree to pay, to the extent permitted by law, any expenses incurred by the School in the collection of tuition, fees and charges or in otherwise enforcing the School's rights under this Agreement, including but not limited to attorneys' and accountants' fees and expenses.

CHOOSE A PAYMENT PLAN: Please indicate your choice of one of the following options. See Tuition and Fees Addendum.

- ONE PAYMENT PLAN:** 100% of tuition and fees, (see Tuition and Fees Addendum) minus any deposits paid due on or before July 31st, 2010. A late fee of \$40 is charged on payments more than five days overdue.
- TWO PAYMENT PLAN:** 50% of tuition minus deposits paid, 100% of the fees (see Tuition and Fees Addendum) and a \$50 per student service charge for non-association members or \$35 per student service charge for association members is due July 31, 2010; 50% plus the payment plan service charge due December 31, 2010. Invoices will be mailed to your address on record approximately 30 days prior to the due date. A late fee of \$40 is charged on payments more than five days overdue. A completed IRS form W-9 for all signers of the contract must accompany signed contract unless this form is already on file with the school.
- FOUR PAYMENT PLAN:** 25% of tuition minus deposits paid, 100% of the fees (see Tuition and Fees Addendum) and a \$45 per student service charge for non-association members or \$30 per student service charge for association members is due July 31, 2010; 25% of tuition plus the payment plan service charge due October 31, 2010 and December 31, 2010; 25% of tuition plus the payment plan service charge due February 28, 2011. Invoices will be mailed to your address on record approximately 30 days prior to the due date. A late fee of \$40 is charged on payments more than five days overdue. A completed IRS form W-9 for all signers of the contract must accompany signed contract unless this form is already on file with the school.
- TEN PAYMENT PLAN (July through April):** 10% of the tuition minus deposit paid, 100% of the fees (see Tuition and Fees Addendum) and a \$25 per student service charge for non-association members or \$20 per student service charge for association members is due July 31, 2010; 10% of the tuition plus applicable service charge due the last day of each month August through March; 10% of tuition plus payment plan service charge due April 30, 2011. An invoice will be mailed to your address for the July and April payments, payment coupons will be provided for you in lieu of monthly statements for months August through March. A late fee of \$40 is charged on payments more than five days overdue. A completed IRS form W-9 for all signers of the contract must accompany signed contract unless this form is already on file with the school.

I (We) understand that, in accepting the Student for enrollment, the School assumes expenses that are not reduced by the child's withdrawal during the school year. I (We) acknowledge that, for this reason, except as noted in the schedule below, the School cannot and shall not refund tuition paid or cancel unpaid obligations when the Student is absent, withdrawn, or dismissed for any reason at any time during the academic year. In the event the Student withdraws or is dismissed for any reason, tuition charges based on the schedule below become due immediately and must be paid within 14 days of leaving the School. School records will not be released unless all financial obligations are met. No portion of fees will be refunded.
